1. EQUIPMENT, RENT AND TERMS OF RENTAL AGREEMENT: The Undersigned, Lessee, hires INFLATABLE RENTALS LLC as Lesser, one INFLATABLE RENTALS LLC unit, identification #: _____ and one blower. The rental fee as stated above is payable in advance from the time of commencement, start time to end time. Once the unit is set up under no circumstances will there be a refund for weather, no park permit, etc.

2. DELIVERY: To the street address specified above by Lessee (Customer). Lessee grants INFLATABLE RENTALS LLC the right to enter the property at the said street address for the delivery and subsequent pick up of the INFLATABLE RENTALS LLC unit at the specified time. Please allow for a 3-hour window for pick up of equipment. Customer is responsible for all equipment until our driver picks it up.

3. TRANSPORTATION EXPENSE: Except as provided herein, all charges in delivering and subsequent pick up of the INFLATABLE RENTALS LLC unit with respect to the delivery address is included in the rental fee noted above.

4. GENERAL RULES TO FOLLOW DURING USE OF THE INFLATABLE RENTALS LLC UNIT:

A. Only compatible age groups and size shall play on the INFLATABLE RENTALS LLC unit at the same time. The maximum number of riders of each group that should play in the INFLATABLE RENTALS LLC unit at one time is:

Unit Size	Children 8 & under	Children 9-12	Teens	Adults
13x13	8	5-6	3-4	3
15x15	10	6-8	4-5	4

B. All riders MUST REMOVE SHOES before playing in the INFLATABLE RENTALS LLC unit.

C. TO AVOID INJURIES, FLIPS ARE NOT ALLOWED AND NO CLIMBING ON THE NETTING.

D. CHILDREN'S SAFETY DEPENDS UPON YOU. YOUR PERSONAL SUPERVISION IS ABSOLUTELY REQUIRED. AS THE LESSEE OF THE INFLATABLE RENTALS LLC UNIT, THE SAFETY OF ALL RIDERS IS YOUR RESPONSIBILITY.

E. Absolutely no "Silly String", gum, candy, food, drinks, animals, shoes, sharp objects or other sticky substances are allowed in the INFLATABLE RENTALS LLC unit. If upon pick up, such cleaning is required then a \$50.00-\$100.00 cleaning fee shall be automatically imposed.

F. DO NOT MOVE the INFLATABLE RENTALS LLC unit from the place where it was installed, this may cause damage to the unit. Rental units that are set up on hard surfaces such as concrete or asphalt must be closely watched to prevent their moving. If the INFLATABLE RENTALS LLC unit moves, pull the corner back to its original location of installation. If the equipment moves off the provided tarp, damage or staining may occur on the bottom of the unit. CAUTION: Keep the INFLATABLE RENTALS LLC unit away from swimming pools.

5. SPECIAL INSTRUCTIONS: THE INFLATABLE RENTALS LLC unit's equipment is reliable. Should the INFLATABLE RENTALS LLC unit begin to deflate:

- (1) The motor may have stopped, in which case, check the cord connection at the outlet near the motor, and remember to keep only the 100 foot extension cord on the outlet (stronger outlets are in the kitchen and laundry room).
- (2) If the motor is continuing to run, check the air intake on the side of the motor for blockage, and check both tubes at the back of the INFLATABLE RENTALS LLC unit for snugness; re-tie if necessary.
- (3) If you cannot correct the problem call INFLATABLE RENTALS LLC (419) 320-1098.

6. SAFE OPERATION ACKNOWLEDGMENT: Lessee ACKNOWLEDGES THAT HE/SHE HAS BEEN INSTRUCTED ABOUT AND FULLY UNDERSTANDS THE SAFE OPERATION OF THE INFLATABLE RENTALS LLC UNIT THAT IS THE SUBJECT OF THIS RENTAL AGREEMENT. Lessee AGREES TO OBSERVE ALL SAFETY PRECAUTIONS. AT NO TIME SHOULD THE UNIT BE UNATTENDED. Lessee ALSO REPRESENTS AND WARRANTS THE SAFE RETURN OF THE UNIT AND HEREBY AGREES TO PAY FOUR THOUSAND (\$4,000) IF IT IS NOT RETURNED.

7. MAINTENANCE: Lessee agrees to keep the INFLATABLE RENTALS LLC unit in the same condition as when received, ordinary wear expected.
